Dear Ms. Tapia-Bouthillier,

On January 15, 2022, the Sacramento Local Agency Formation Commission received a request from Foreperson Deanna Hanson seeking a detailed timeline for conducting a municipal service review (MSR) on Del Paso Manor Water District.

As you are aware, LAFCo responded to the recent Grand Jury Report, titled "Del Paso Manor Water District Flooded with Public Safety Dangers." LAFCo indicated in was in agreement with the need to conduct an MSR on Del Paso Manor Water District but LAFCo sought an adjusted timeline for the completion of the MSR. The Grand Jury Report recommended work on the MSR start in January 2022 and end by June 2022. For various reasons LAFCo countered that work should begin in May 2022 and be completed by November 2022. The letter from Foreperson Hanson states the timeline adjustment was acceptable but LAFCo needed to provide "a detailed timeline on the steps which will occur in 2022 to make certain an MSR is finalized."

This letter contains a proposed timeline. There are caveats, of course. Several factors could affect the completion of the MSR, primarily contingent upon Del Passo Manor Water District being able to complete and/or provide the studies the Grand Jury Report identified. Another factor is the number of qualified consultants who respond to the LAFCo RFP. If an insufficient number of consultants respond, then LAFCo would be forced to re-circulate or extend the response deadline. Given these, this is the proposed timeline:

Again, there are several factors that could affect this timeline, some outside of LAFCO's control, and a definitive schedule will not be known until a qualified consultant has been selected and contracted. Nevertheless, this is the best estimated timeline staff can create based on past experience. But this timeline allows for the completion of a draft report by November 2022 and LAFCo will ensure the Grand Jury receives a copy for its review and comment.
